FINAL RESULTS FOR THE KATIMA MULILO URBAN CONSTITUENCY BY ELECTIONS IN THE ZAMBEZI REGION

We hereby wish to inform the Namibian nation that the Electoral Commission of Namibia (ECN) has successfully concluded the Regional Council by-election for the Katima Mulilo Urban Constituency held on Wednesday, 25th August 2021.

The polling stations all opened on time at 07h00, after pre-poll proceedings were conducted in the presence of political party agents to ensure that all voting materials were in order and that there were no ballot papers in the ballot boxes at the start of the poll. The by-election was conducted in a calm and peaceful atmosphere, with no incidences recorded.

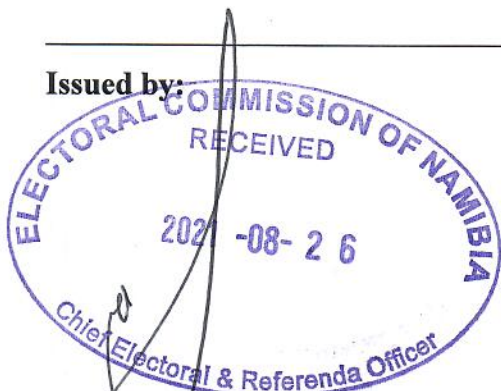
