OFFICIAL RESULTS FOR THE REGIONAL COUNCIL ELECTION FOR THE SWAKOPMUND CONSTITUENCY

The Electoral Commission of Namibia (ECN) has successfully concluded the Regional Council by-election for the Swakopmund Constituency on the 12th August 2022. The by-election was conducted in a calm and peaceful atmosphere.

The results as announced by the Returning Officer are as follows:
