PROVISIONAL STATISTICS FOR THE MOSES //GAROËB CONSTITUENCY SUPPLEMENTARY REGISTRATION OF VOTERS

The Electoral Commission of Namibia (ECN) hereby announces the successful completion of the Supplementary Registration of Voters (SRV) exercise, which was conducted from 31st October - 02nd November 2022 in terms of Section 38 (1) of the Electoral Act, Act 5 of 2014.

As per the Electoral Act, Act 5 of 2014, a Supplementary Registration of Voters (SRV) is to be conducted before any election in accordance with Section 38(1) read together with Section 25 (2) of the Act. The purpose of an SRV before holding of an election is to include in the voter's register persons who have since turned 18 years of age after the last registration; persons who have moved from one constituency to another; or persons whose voter registration cards are reported lost or damaged; and any other applicant who qualifies for registration in terms of section 22(1) of the Electoral Act. The voters register for the constituency prior to the conduct of the SRV stood at 41 206, while during the SRV a total number of 929 eligible voters registered, bringing the provisional voters roll to a number of 42 135. In addition, a total number of 619 duplicate voter registration cards have been issued.

In terms of the Electoral Act, the Provisional Voters Register (PVR) will be displayed for public scrutiny and objections on 09th November 2022, at the Moses //Garoëb Constituency Office, 670 Outapi Street, Havana, Windhoek. The final voters register will be available on 02nd December 2022.



Nomination Period

The nomination of candidates commences today, Tuesday, **08**th **November 2022**. The last day for nomination of independent candidates is **21**st **November 2022**, whilst, for political parties the **23**rd **November 2022**. Nominations are submitted to the Returning Officer at the **ECN Headquarters**, **67-71 Van Rhyn Street**, **Windhoek North**, **Room 126**, **First floor**. The ECN encourages the submission of nomination to be done within the prescribed period.
