#### SECTION I: INSTRUCTIONS TO BIDDERS

#### 1. Rights of Public Entity

The Electoral Commission of Namibia reserves the right:

- (a) to split the contract as per the lowest evaluated cost per item, or
- (b) to accept or reject any quotation; and
- (c) to cancel the quotation process and reject all quotations at any time prior to contract award.

#### 2. Preparation of Quotations

You are requested to quote for the items mentioned in Section III by completing, signing and returning:

#### 3. Validity of Quotations

#### 9. Opening of Quotations

Quotations will be opened internally by the Public Entity immediately after the closing time referred to in instruction 8 above. A record of the Quotation Opening stating the name of the bidders, the amount quoted, the presence or absence of Bid Securing Declaration, will be posted on the website of the Public Entity and available to any bidder on request within three working days of the Opening.

#### 10. Evaluation of Quotations

The Public Entity shall have the right to request for clarifications in writing during evaluation. Offers that are substantially responsive shall be compared on the basis of price or ownership cost, subject to Margin of Preference where applicable, to determine the lowest evaluated quotation.

#### 1. PURPOSE

- 1.1 The purpose of this Request for Bid is to invite Suppliers (hereinafter referred to as "bidders") to submit bids for the supply and delivery of security seals to the Electoral Commission of Namibia (ECN), with a period of 23 September 4 October 2024.
- 1.2 This bid is restricted to suppliers with capacity and capability to supply and deliver security seals conforming to the requirements and standards set out in **Section 6** of this bid.

#### 2. BACKGROUND

2.1 The ECN has identified the need for supply and delivery of security seals and the appointment of a service provider to provide these goods is thus imperative.

#### 3. SCOPE OF BID

- 3.1 The invitation of bid is aimed at ensuring that election materials are supplied and delivered to the ECN.
- 3.2 The election materials specified under this bid must be supplied and delivered to the ECN Head Quarters (HQ), **Registration and Planning** within timeframe specified in this document.

#### 4. SPECIFIC PRE-REQUISITES

- 4.1. Prospective bidders must be prepared to deliver high quality products right first time and at the right time.
- 4.2. Prospective bidders must initial every page and sign the last page of this bidding document as a requirement to declare acceptance of the conditions and requirements specified in this bid.
- 4.3. In case of any prospective wants to declare <u>not to accept</u> any of the specified conditions or requirements specified in this bid, this must be done on a separate sheet to be provided by the bidder.

  - ii) Valid Good Standing Certificate with Social Security
  - iii) Valid Inland Revenue Good Standing Certificate from the NAMRA
  - iv) Valid Affirmative Action Compliance Certificate
  - v) Written undertaking in terms of Section 138 of the Labour Act

#### 7. ADMINISTRATIVE REQUIREMENTS
